MEMBER SERVICES: IN 2016-17 AAFB DISTRIBUTED 45,291,575 POUNDS OF FOOD. AAFB STAFF SUPPORTED TRANSPORT OF 811 TOTAL TRACTOR TRAILER LOADS OF FOOD. AAFB ALSO SUPPORTED PURCHASING FOOD THROUGH SEVERAL PROGRAMS RESULTING IN A TOTAL BENEFIT OF \$242,253 AND MORE THAN 1 MILLION POUNDS. PURCHASES WERE CONDUCTED PRIMARILY TO PROVIDE FOOD BANKS WITH PRODUCE DURING NON-GROWING SEASONS. BY WORKING IN PARTNERSHIP WITH MEMBER FOOD BANKS, AAFB SECURED AN ADDITIONAL 217 LOADS OF FOOD THROUGH FEEDING AMERICA'S "CLUSTER" PROCESS AND RESULTED IN AN ADDITIONAL 7 MILLION POUNDS OF FOOD FOR ARIZONA FOOD BANKS.
