MEMBER SERVICES: AAFB HAS ONE CONSISTENT MEMBER SERVICES AND LOGISTICS GOAL: TO GET MORE AND BETTER QUALITY FOOD THROUGH THE FOOD BANK NETWORK AND INTO THE HANDS OF THOSE WHO NEED IT MOST. IN FY 2017-2018 THE AAFB LOGISTICS TASK FORCE DISTRIBUTED 45,261,308 POUNDS OF FOOD. AAFB'S TWO DRIVERS TRANSPORTED 801 TOTAL LOADS OF FOOD, MOST OF WHICH WAS PRODUCE. 392 OF THE LOADS AAFB DRIVERS TRANSPORTED SUPPORTED THE AZ FOOD BANKS PRODUCE INITIATIVE, WHICH HELPED THE NETWORK SHARE MORE THAN 85 MILLION POUNDS OF FRESH AND HEALTHY FOOD TO BENEFIT CLIENTS STATEWIDE. THE REMAINING TRANSPORTATION INCLUDED FOOD PURCHASES AND SHARED LOADS OTHER THAN PRODUCE. IN FY 2017-2018, AAFB CONTINUED TO SUPPORT OUR FOOD BANKS BY PURCHASING HIGHLY NUTRITIOUS FOOD FOR CLIENT. THIS INCLUDED FOOD PURCHASED WITH STATE

THESE SOLUTIONS ARE BASED ON THE BARRIERS SCHOOLS FACE IN SERVING BREAKFAST, AND NEED IN THE AREA. CHILDREN AND YOUTH PROGRAM MANAGERS FORM RELATIONSHIPS WITH EVERYONE FROM TEACHERS TO FOOD SERVICE DIRECTORS TO UNDERSTAND WHAT EACH SCHOOL NEEDS IN ORDER TO IMPLEMENT FEE AND REDUCED PRICE BREAKFAST AND/OR ALTERNATIVE BREAKFAST MODELS SUCH AS BREAKFAST AFTER THE BELL OR GRAB AND GO.

ADVOCACY AND EDUCATION: AAFB HELPED SECURE A ONE-TIME \$1 MILLION APPROPRIATION AS PART OF THE STATE BUDGET. THESE CRITICAL FUNDS ARE BEING USED AT THREE LARGE FOOD BANKS, ST. MARY'S FOOD BANK ALLIANCE, UNITED FOOD BANK, AND COMMUNITY FOOD BANK OF SOUTHERN ARIZONA FOR SPECIAL PROJECTS. THE REMAINING \$500,000 IS BEING DISTRIBUTED THROUGH AAFB AS PART OF A COMPETITIVE PROPOSAL PROCESS. THIS FUNDING WILL BE USED BY AGENCIES SERVED BY THE FOOD BANKS TO INCREASE REFRIGERATION CAPACITY, ESPECIALLY IN RURAL LOCATIONS. AAFB ALSO ACTIVELY PROTECTED THE HUNGER LINE ITEM IN THE DES BUDGET WHICH SUPPORTS STORAGE AND DISTRIBUTION OF FEDERAL COMMODITIES AND OTHER DONATED PRODUCTS. ON A NATIONAL LEVEL, AAFB HAS BEEN DEDICATED TO DEFENDING HUNGER RELIEF AND SNAP IN THE FARM BILL.
